



Brief: 2024 Generation Al Survey

Introduction

Artificial intelligence is set to define this generation. As today's young people have grown up, Al systems have advanced in parallel. Automated resume checkers, social media's uncanny recommendation systems, and Al-powered chatbots are just the beginning. And we're not separate from this revolution. As teenagers ourselves, we can see Al will shape our education, careers and lives.

For the past two years, our parents, peers, and policymakers have asked us many questions about the hopes and fears of today's young people with this technology. The Center for Youth and AI (YouthAI) surveyed teenagers on AI's impact on their lives – a cohort we're terming "Generation AI." Here's what we found.





Key Findings


- The vast majority of young people view AI risks as a top issue for lawmakers to address. 80% said AI risks are important for lawmakers to address, compared to 78% for social inequality and 77% for climate change only healthcare access and affordability was ranked higher at 87%. A significant portion of young people are concerned about advanced AI and its potential risks. 57% of respondents are somewhat or very concerned about advanced AI, compared to 39% who aren't. 45% believe AI could pose an extinction risk to humanity.
- Nearly three in five were concerned about Al-generated misinformation and deepfakes. 59% are concerned about Al-generated misinformation, 58% are concerned about deep fakes, and 51% are worried about Al used for mass surveillance. 47% were concerned about advanced autonomous Al escaping human control.
- Approximately half of the respondents reported using AI tools like ChatGPT several times a
 week or more. Another 18% used it a few times a month, and 35% used it either rarely or
 never.
- A majority of young people are factoring AI into their career planning. 65% of respondents
 have considered AI automation as a factor in their career plans, indicating widespread
 awareness of AI's potential impact on the job market.
- Young people are generally supportive of Al-generated creative works. 57% are in favor of Al-generated art, film, and music, while only 26% oppose it. This suggests a relatively low level of concern about Al's impact on intellectual property.
- There's strong opposition to romantic relationships between humans and Als. 68% of respondents find such relationships unacceptable, compared to only 24% who find them acceptable. However, attitudes towards friendships with Als are more evenly split, with 46% finding them acceptable and 44% unacceptable.













Q7. How important is it that lawmakers address potential risks of Al?

Methodology: All figures, unless otherwise stated, are from YouGov Plc. Total sample size was 1,017 teens (aged 13 to 18). Fieldwork was undertaken between July 30th, 2024 to August 11th, 2024.
